MESSAGE FROM THE EXECUTIVE DIRECTOR

As 2023 draws to a close, I reflect with gratitude on my six years as the Executive Director of Advocates of Silenced Turkey. It's a privilege to work alongside compassionate and knowledgeable human rights advocates like all of you.

Despite the global challenges to democracy and justice, your unwavering energy remains inspiring. As we take a pause to reconnect with family, friends, and ourselves during this season, I am optimistic about what 2024 holds for the Advocates of Silenced Turkey family and the persecuted people we serve. This optimism is fueled by the life-changing work our volunteers undertake daily, highlighted within the pages of this annual report.

The political climate in Turkey has grown increasingly tumultuous since the so-called coup attempt on July 15,

2016. The government's collective persecution of political dissidents and critics has resulted in the dismissal of over 130,000 individuals from their jobs, with arbitrary arrests and lengthy pretrial detentions becoming tools to suppress opposition. The harsh persecution has also affected the lives of family members, estimating around 10 million people impacted.



In 2023, we regretfully witnessed several egregious cases of human rights abuses, including the arbitrary and disgraceful detention of Huda Kaya, a former DEM MP and a prominent human rights advocate. The refusal to release Ramazan Taskiran, a prisoner in the advanced stages of cancer, was particularly distressing. Similarly, the unlawful detention of Nurcan and Abdulkadir Arslan, parents of seven-year-old quintuplets, and the tragic death of Yusuf Kerim, a six-year-old cancer patient, were deeply troubling instances. The unjustifiable detention of Can Atalay, an elected MP, persisted despite the Supreme Court's decision to overrule it. Additionally, the ongoing imprisonment of Serife Sulukan, a paralyzed prisoner who cannot survive without assistance, further highlights the dire human rights conditions faced by the people of Turkey. These are just six examples among the countless instances of human rights misery endured by the people of Turkey.

In alignment with the distressing stories of persecution outlined above, prison conditions in Turkey, marked by deplorable conditions, particularly for imprisoned women, the sick, the elderly, and those prisoners of conscience, are among the most severe human rights abuses. Despite international rules protecting these individuals, incidents of violence and ill-treatment persist within prisons.

Correspondingly, recent years have seen an alarming increase in gender-based violence and discrimination against women in Turkey, especially those from marginalized communities. After the 2016 coup attempt, women's rights and agency became viewed as a threat, leading to the targeting of women as anti-government dissidents or terrorists. Women from various communities face discrimination, hate speech, sexual harassment, and physical violence due to their gender, ethnicity, and political beliefs. The withdrawal from the Istanbul Convention in

2021 exacerbated violence against women, resulting in a significant rise in femicide. In 2022 alone, 334 women were killed, with over 300 femicide cases identified so far in 2023.

Discriminatory practices against various groups, including Kurds, Alevis, Gulen movement volunteers, and even children, continue unabated. Thousands of children, often with their families, have faced perilous journeys; legal protections for women with children were neglected for those affected by the state of emergency decrees (KHKs) and OHAL (state of emergency). The failure to implement these protections results in significant rights violations against women and children, including unborn and newborn infants. AST's photographic documentation, "Being the Other Child in Turkey" interprets how the vulnerable bodies and souls of these children are impacted by gross rights violations and the challenging ordeals they endure.

Furthermore, the Turkish government's persistent torture cases, both under police custody and on black sites, represent a horrifying crime against humanity. Those involved in torture are protected, rewarded with impunity, and often promoted despite legal actions being filed against them. Since the 2016 coup attempt, torture has become systematic in Turkey, affecting a growing number of victims.

From 2016 to 2023, in the midst of the human rights crisis, numerous individuals fell victim to grief, stress, and illness. As of November 2023, **we have documented 952 casualties** attributed to the state of emergency (OHAL) and decree laws (KHK), which include 90 children. This encompasses suspicious deaths in prisons, those who took their own lives, and those who lost their lives while trying to flee Turkey across the Meriç and Aegean, encountering denial to return to their home countries.

The numerous state-sanctioned human rights abuses in Turkey are too extensive to enumerate. AST engages in a range of activities, from organizing conferences and panels to writing reports submitted to relevant organizations and committees. Collaborating with other organizations is crucial for sharing causes, learning from others' stories, and amplifying our own narratives.

In response to the pandemic and global crises, AST has adapted its strategies, incorporating virtual protests, panels, and written works, including reports and books. Survivor interviews are shared through books, providing a platform for the voices of those persecuted.



AST encourages people to write letters to decision-makers and focuses on youth empowerment, recognizing the significant role young advocates play. Collaboration between youth and adults is essential in all aspects of our activities, including the use of art and music to advocate for human rights.

In 2024, AST remains committed to being the voice of the voiceless, defending fundamental rights, educating and motivating human rights advocates, urging leaders to prioritize human rights, and convening groups for collaborative action.

Let us unite in the fight against violence, inequality, and injustice. Through solidarity and political unity, we can amplify our strength, break down prejudices, and work towards a world free from violence and injustice. Thank you for being part of this crucial cause.

The Freedom Convention Turkey shines a spotlight on critical global issues, including democratic decline, erosion of the rule of law, misuse of anti-terror laws, limited freedom of expression, and human rights setbacks. It highlights the essential role of international bodies in addressing rights violations and explores utilizing ECHR and UN avenues for change. Celebrating Human Rights Day on December 10th, the convention aims to deepen awareness of Turkey's challenges and offer strategies to unite with the global human rights community, amplifying voices stifled by oppressive regimes.

Human rights refers to all the privileges and rights that an individual has just by virtue of being human; regardless of race, religion, sexual orientation, or other characteristics. Throughout history, different treaties, decrees, and covenants have increasingly take human rights under protection on a global scale. In other words, the concept of human rights is widely institutionalized. International human rights rules require states to guarantee that their citizens have access to human rights and to protect them from any infringements or abuses of those rights. However, the current Turkish government goes beyond simply failing to uphold these duties and denying them by persecuting the people who support and seek out fundamental freedoms like the right to free speech.

AST (Advocates of Silenced Turkey), as an NGO has relentlessly been working since its foundation in 2017 to champion human rights which are harshly violated by the state in Turkey, with the hopes of supporting a reestablishment democratic values.

Ebubekir and Gonca symbolize a larger group of over a million individuals from Turkey accused



A JOURNEY OF REMEMBRANCE AND HUMAN RIGHTS ADVOCACY

The seeds of the Social Genocide Exhibition, which I have the privilege of coordinating, were sown on February 24, 2022, under the banner of Commemoration for the Persecuted Lives in Turkey and Art Exhibition. This commemorative event marked the beginning of an inspiring journey, showcasing the artistic talents of individuals unjustly detained in Turkish prisons. Their creations, ranging from calligraphy to marbling and various other forms of art, were transported from Turkey to the United States, igniting a spark of inspiration within us.

Our mission was clear: to shed light on the lives of individuals abandoned to the darkness of civil death in Turkey, along with the cherished possessions that defined their existence. With this purpose in mind, months of relentless effort culminated in the creation of the Social Genocide Exhibition, which would eventually travel across the United States. The exhibition opened its doors to the public for the first

time on June 5, 2022, at the **Wyndham Hotel in New Jersey.** With the tremendous support of Kari O'Rourke, a member of AST Advisory Board in Kansas City, and her associates, we reached thousands of visitors at three different venues in Kansas City in September, 2022. On May 8, 2023, we gathered with visitors in **Washington, D.C.** In the past year, the exhibition made a significant impact as it toured six different programs in cities such as **Chicago, Michigan, Indiana, and Cleveland.**

Allow me to introduce you to some of the remarkable projects that have sprung forth from the Social Genocide Exhibition. The AST Event Hall in New Jersey now serves as a permanent home to 40 invaluable relics from the exhibition. Currently, we are working towards sharing these stories with a broader audience by displaying them in cultural centers and human rights corners in cities like Chicago, Rochester, and Pittsburgh.

In the realm of literature, interviews conducted with the dedicated team members who worked on the exhibition and the stories behind the displayed relics have been eloquently documented by Mina Leyla in her book titled 'Bloody Tie.' This literary work is now accessible to readers on Google Books and Google Play. In addition, our **American friend Kari O'Rourke** successfully completed her **PhD thesis under the title 'Social Genocide in Turkey,'** which has been officially accepted.



To provide some insight into the preparation and creation of the exhibition, we firmly believed that individuals' belongings bore witness to the vivid experiences of their suffering. Initially, these relics were gathered in Turkey, carefully preserved in the homes of our friends across various cities. They eventually made their way to America, either through shipments or the luggage of visiting relatives.

The Social Genocide Exhibition stands as a collective repository of hundreds of relics, encompassing the experiences of individuals from diverse ethnic backgrounds, beliefs, and ideological perspectives. Notably, it includes relics from Kurds, Alevis, volunteers of the Hizmet (Gulen) Movement, women, children, journalists, politicians, and activists.

What unites us in the Social Genocide Exhibition transcends the boundaries of religion, ethnicity, or worldview. It is our shared commitment to kindness and love. The exhibition

aspires to give a voice to individuals of every hue and listen attentively to their stories, with the ultimate goal of sharing these narratives with the world. It meticulously safeguards the memories of hundreds, including Taybet Ana, a Kurdish mother who was tragically shot with ten bullets by security forces in the midst of a street in Silopi, Hatice Akcabay who lost her life in Meriç, along with her three children while fleeing the persecution, Ali İsmail Korkmaz, who tragically lost his life during the Gezi protests, Garibe Gezer, a young woman who met a harrowing end through torture in prison, imprisoned journalist Mehmet Baransu, and Şehit Murat Tekin, who fell victim on a bridge.

Our endeavor to illuminate human rights violations and bear witness to the true victims of oppression has led us to encompass over 200 relics, each a poignant testament to resilience and the indomitable human spirit. The Social Genocide Exhibition stands as a tribute to common human values, a symbol of remembrance, and a powerful platform for justice. I would like to extend my sincere appreciation to those whose invaluable contributions have made this crucial project possible. We welcome your support in our mission to expand this exhibition, solidify its presence in select locations, and invite your participation in both organizing events and contributing relics to this noble cause.







































REPORTS

As AST, our primary objectives revolve around raising awareness on various platforms and, based on the knowledge we disseminate, taking impactful action. This action primarily involves urging those in positions of power to restore the rule of law in Turkey, ensure human rights, and hold the Turkish government accountable for its harsh actions.

A crucial aspect of our proactive approach is the creation of reports, which we submit to relevant entities, committees, and commissions. To date, we have authored and **shared 53 reports,** covering topics such as the dire conditions in Turkey's prisons, the plight of sick and elderly inmates, violations of women's rights, global renditions orchestrated by the government, instances of torture, and the erosion of the rule of law.

With the sincere hope that these reports contribute significantly to the human rights cause, we remain committed to our work.





Women's Rights Violations by the Turkish Legal System

The intent of this report is to declare the victims of the 'New Turkey,' especially women with children who have been under persecution since the July 15, 2016 coup attempt. Although the Turkish government does not promote transparent data on the number of children imprisoned with their mothers.

Freedom Convention

Turkey Freedom Forum is a unique convention for human rights activists, intellectuals, and policymakers focused on human rights violations in Turkey organized by AST. In pursuance of justice and peace, this forum aims to bring hundreds of human rights defenders and activists together and to foster the dynamics to mobilize. This report will focus on five unique panel topics and will highlight outstanding discussions.

COUP AGAINST JUDICIARY!

THE TRANSFORMATION OF THE TURKISH JUDICIAL SYSTEM AFTER DECEMBER 17-25 CORRUPTION CASES AND JULY 15, 2016 COUP ATTEMPT

The integral principle of democratic regimes, and of a state of law, is the independence and impartiality of the judiciary. As the judiciary is weakened by being exposed to political interventions in countries with weak democratic foundations, it can become a tool of intimidation by dictatorial administrations.

Collapse of Rule of **Law in Turkey**

There are numerous reports illuminating the collapse of rule of law and the judicial independence in Turkey. The lack of fair trials, the denial of the right to defense, and political interference in ongoing cases summoned close-up scrutiny from international organizations to the nature of post-coup trials, causing debilitating damage to the credibility of trials at all.



DID YOU KNOW THAT ECHR RULED AGAINST THE GOVERNMENT OF TURKEY?: **NO PUNISHMENT WITHOUT LAW!**

The European Court of Human Rights ruled that the rights of a Turkish teacher, Yalcinkaya, convicted of what prosecutors called terrorism offences had been violated because the case was largely based on his use of a phone app.

The court said its ruling could apply to thousands of people convicted following an attempted coup in Turkey in 2016 after the prosecution presented use of the ByLock encrypted messaging app as evidence of a crime.

In its judgement, the court found the case had violated the European

Convention on Human Rights, namely the right to a fair trial, the right to freedom of assembly and association and the right of no punishment without law. The ruling is a milestone in the ongoing pursuit of justice and democracy in Turkey underscoring the role of international pressure in urging not only Turkey but also other nations to adhere to the rule of law.

Erdogan's Long Arms: Abductions in Turkey and Abroad

It is no secret that Turkey's authoritarian political Islamist regime, headed by the ruling Justice and Development Party (AKP) and its ruler Recep Tayyip Erdoğan, has long been suppressing opposition in the country.

Erdogan's Torture Squads

Government employees who have been involved in the use of torture have been protected by government institutions and officials in Turkey for years and rewarded with impunity. Even when a lawsuit is filed against them, it is ensured that these employees continue their duties and even receive promotions as they are prevented from being sentenced and imprisoned.













Sick and Elderly Political Prisoners in Erdogan's Turkey

The jails in Turkey have long been mentioned in the same breath as inhumane actions and the breach of even the most basic rights, especially against the political prisoners. The violations have reached to unprecedented levels in parallel with the emergence of the current political-Islamist authoritarianism.

Documenting the narratives of persecuted individuals in Turkey, specifically their real-life experiences, constitutes a significant aspect of our work. To date, we have released numerous books in various languages, comprised of these stories obtained through interviews with survivors of the extensive purge. Additionally, our advocacy extends to academic articles, which cater to a diverse audience and present the experiences of human rights abuses and injustices from an intellectual perspective. In this regard, advocates from AST have authored a range of articles addressing distinct human rights issues in Turkey. These topics include genderbased discrimination and violence in post-coup Turkey, the challenges faced during the 2023 elections, as well as the systematic targeting and silencing of educators and students associated with the Hizmet movement, along with broader human rights conflicts and dislocation. AST has also crafted comprehensive reports as the Universal Periodic Reviews (UPR) for








DID YOU KNOW THAT TURKEY'S GOVERNMENT IS IMPRISONING WOMEN WITH BABIES AND WOMEN IN POSTPARTUM ARBITRARILY, DESPITE INTERNATIONAL LAWS ADVISING AGAINST THEIR INCARCERATION?

The government of Turkey is also imprisoning both parents who are only caregivers of young children although COMMITTEE on the RIGHTS of the CHILD strictly states that "In sentencing parent(s) and primary caregivers, noncustodial sentences should, wherever possible, be issued in lieu of custodial sentences, including in the pre-trial & trial phase.

DID YOU KNOW?

Alternatives to detention should be made available and applied on a case-by-case basis, with full consideration of the likely impacts of different sentences on the best interests of the affected child(ren)."

As a state party to the UN Convention on the Rights of the Child, #Turkey is mandated to "undertake to ensure the child such protection and care as is necessary for his or her wellbeing" (Article 3), "ensure to the maximum extent possible the survival and development

of the #child" (Article 6), and "ensure that a child shall not be separated from his or her parents against their will" (Article g). Yet, the Turkish government infringes upon these vital articles essential for the wellbeing of critically ill children like Yusuf Kerim Sayin, who tragically succumbed to cancer, Zuleyha Erkol, whose mother passed away from cancer months ago, and whose father is imprisoned despite being the sole caretaker, and the quintuplets, who are children with special needs, along with their parents being incarcerated.



DID YOU KNOW THAT THE EUROPEAN COURT OF HUMAN RIGHTS (ECHR) NOTIFIED THE TURKISH GOVERNMENT ABOUT OVER 1000 APPLICATIONS RELATED TO CONVICTIONS BASED ON THE USE OF THE BYLOCK MESSAGING APPLICATION, FOLLOWING THE YALÇINKAYA JUDGMENT?

The European Court of Human Rights (ECtHR) has informed Ankara **about 1,000 pending applications** related to convictions for Gülen movement membership based on the use of the **ByLock smartphone application.** This comes after a significant ruling in September that declared the use of the ByLock application as neither a reliable piece of evidence nor a criminal offense.

This development follows the Grand Chamber decision by the ECtHR in the case of Yüksel Yalçınkaya v. Türkiye in September 2023. In this verdict, the ECtHR determined that Turkey had breached three articles of the European Convention on Human Rights (ECHR) in the case of former

teacher Yüksel Yalçınkaya: Article 6, pertaining to the right to a fair trial; Article 7, addressing no punishment without law; and Article 11, regarding freedom of assembly and association.































ANIMATIONS






I will never forget you as long as I live. You are the light to my eyes. My Garibe was unique. I salute you all.

The phrase "a particular bundle of silences" caught my attention immediately. The desire expressed by the group of people who will become the participants in this proposed study is that they want to un-silence their voices. In the fourth proposed group of participants for the study, I will examine more than 40 stories and artifacts of lives that have been lost as a part of Turkish President Recep Tayyip Erdoğan's regime's efforts to eradicate the Hizmet people. I was invited to be a speaker at a social genocide awareness event in New Jersey in June 2022. Afterwards, I organized a group of volunteers to bring the exhibit to Kansas City and in September 2022 we presented the exhibit in three venues and I named the exhibit "Un-Muted." The stories of what -happened to these people are the counternarratives to what the mainstream media in Türkiye presents. The story of Garibe Gezer is gutwrenching. She was arrested and sent to prison in 2016 and died in 2021 as the result of prolonged torture, isolation and repeated rape. After we shared her story through the exhibit, her mother sent a video message which the Advocates of Silenced Turkey (AST) volunteers translated to English for us. By sharing Garibe's story we ensured that her voice remains present in the historical record despite the efforts of the dominant regime's attempts to silence it. It is critically important to ensure are not lost to the narrative of dominance and opperession.





















































TURKEY'S HUMAN RIGHTS REPORT IN NUMBERS SINCE THE DECLARATION OF THE STATE OF EMERGENCY:

- ▶ More than 1,576,000 people were investigated for being members of an armed terrorist organization
- ▶ More than 300,000 people were detained
- ≥ 234,419 passports were revoked
- ▶ More than 152,000 civil servants were dismissed after the declaration of the state of emergency (OHAL).
- > 4,500 judges and prosecutors were dismissed. 4,000 of them were arrested.
- ▶ **1,605** prisoners have been reported to have serious diseases and **604** of whom had major health problems making it impossible to stay in prisons. Their right to life is threatened.
- ▶ 36 people drowned in the waters of Maritsa river and the Aegean sea while trying to escape persecution in their own countries.
- ▶ 144 people have been kidnapped by the state's intelligence forces since 2016, some of them later appeared devastated by grueling tortures. Some are still missing.
- ▶ After the state of emergency, more than **800** people expelled with statutory decrees died due to heavy psychological traumas they had to face or due to fatal accidents in their new but harsh workplaces.
- ➢ For the first time in Turkey's history, more than 17,000 women were arrested for political reasons.
- ▷ A total of over 3,000 children under the age of 6 have been locked in prisons with their mothers, most of whom were detained for political reasons. At one point, nearly 900 hundred babies were growing inside the dark wards of Turkey's prisons.
- > **5,728** institutions were closed and more than **40,000** people working in these institutions were dismissed without any rights, compensation.

- ▶ A total of 23,427 academics either lost their right to rank or were expelled. Among them, 406 were the signatories of the declaration of peace, 3,041 were discharged from universities that were closed and 7,508 were dismissed from the public academic institutions due to their alleged affiliations with certain political and social groups.
- ▶ With the statutory decrees, **1,598** associations, **560** foundations, **29** unions, **33** television channels, **34** radio channels, **90** newspapers and magazines were closed.
- With the statutory decrees, the doors of 1,604 high schools, primary and kindergartens, 360 private lessons and study centers, 847 student dormitories and 15 private universities were locked.
- ▶ 985 commercial companies were confiscated with the statutory decrees. The amount of usurped or confiscated assets in the form of personal and corporate bank accounts and movable and immovable assets exceeded \$30 billion dollars.
- > 44 journalists were physically attacked.
- ≥ 23 journalists were verbally threatened.
- > 57 journalists were detained for 144 days in total.
- ▶ 6 journalists were beaten in custody.
- ▶ 43 journalists in prison.
- □ Trustees were appointed to 59 municipalities that the Kurdish opposition party
 HDP won in the local elections.
- ▶ Prisons have become overcrowded due to arbitrary detention and political revenge operations. Despite its total capacity of 233,194 people, the number of detainees and convicts remaining in Turkish prisons as of 31 March 2022 is 314,502. In terms of prison density rate according to population, Turkey ranked first among the Council of Europe member states with about 3,700 prisoners per 1 million people.
- ▶ The government boasts of spending **20 billion** TL to build **227** new prisons while counting its big investments. **126** of these prisons were built after 15 July 2016.
- > Only in the last two years, **104** detainees and convicts have lost their lives in prisons.
- ▶ An estimated **1.8 million** books were burned or destroyed in 2016.
